- LETTER OF AWARD FROM GOLDEN ARMANI SDN BHD TO VESTLAND RESOURCES SDN BHD, A WHOLLY-OWNED SUBSIDIARY OF THE COMPANY

1. INTRODUCTION

The board of directors of the Company (“**the Board**”) is pleased to announce that its wholly-owned subsidiary, Vestland Resources Sdn Bhd (“**VRSB**”), had on 26 June 2026 accepted a Letter of Award dated 26 June 2026 awarded by Golden Armani Sdn Bhd [Registration No. 201001014400 (898634-H)] (“**GASB**”) to undertake the superstructure works for one (1) block of nine (9)-storey stratified factory and related facilities, located at PT 84557 & 84558, Mukim Bukit Raja, Klang, Selangor Darul Ehsan (“**Contract**”) for a contract sum of RM135,000,000.00.

2. INFORMATION ON GASB

GASB was incorporated in Malaysia as a private company limited by shares having its address at Level 17, Subplace Boulevard, No. 6, Jalan Juruanalisis U1/35, Seksyen U1, 40150 Shah Alam, Selangor Darul Ehsan.

The principal activities of GASB consist of property development, construction, money lending services, investment holding, trading and service provider.

3. SALIENT TERMS OF THE CONTRACT

3.1 Scope of work

The scope of works to be carried out under the Contract comprises the design, approval, construction, completion, testing and commissioning of the superstructure works (“**Contract Works**”).

3.2 Contract Works period

Completion of the Contract Works shall be thirty-six (36) months from the commencement date, which will be notified later by GASB.

4. FINANCIAL EFFECTS

The Contract will have no effect on the issued share capital and substantial shareholders’ shareholdings of the Company as there is no issuance of new ordinary shares in the Company.

The Contract is expected to contribute positively towards the earnings and net assets of the Company and its subsidiaries (“**Vestland Group**”) for the duration of the Contract assuming no material delay in the timing as stated in Section 3.2 above.

5. RISK FACTORS

The Contract is in the ordinary course of business for VRSB and VRSB does not foresee any exceptional risks other than the normal operational risks associated with the Contract.
